SUMMARY ANNUAL REPORT FOR PETSMART SMARTCHOICES BENEFIT PLAN

This is a summary of the annual report of the Petsmart Smartchoices Benefit Plan (Employer Identification Number 94-3024325, Plan Number 501) for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Petsmart, LLC has committed itself to pay certain medical and dental claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Vision Service Plan, Cigna Health and Life Insurance Company and Affiliates (CIGNA), United Behavioral Health dba Optum, Life Insurance Company of North America and Triple S Salud, Inc. to pay certain life, accidental death & dismemberment, medical, dental, vision, temporary disability, long-term disability, employee assistance program, organ and tissue transplant and teleconsult claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2022 were \$15,487,875.

SUMMARY ANNUAL REPORT FOR PETSMART, INC. SAVESMART 401(K) PLAN

This is a summary of the annual report for the PetSmart, Inc. SaveSmart 401(k) Plan (Employer Identification Number 94-3024325, Plan Number 001) for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by a trust fund. Plan expenses were \$42,424,318. These expenses included \$994,636 in administrative expenses and \$40,754,011 in benefits paid to participants and beneficiaries, and \$675,671 in other expenses. A total of 52167 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$465,866,090 as of the end of the plan year, compared to \$538,314,308 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of -\$72,448,218. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of -\$30,023,900, including employer contributions of \$14,401,420, employee contributions of \$44,004,500, other contributions/other income of \$5,590,962, and earnings from investments of -\$94,020,782.
